Significance is indicated as follows: a,  $P < .05$ ; b,  $P < .01$ ; c,  $P < .001$ .

In the article, "Preventing Injuries to Children Through Compulsory Automobile Safety Seat Use," by Wagenaar and Webster (*Pediatrics* 1986;78:662-672), reference 23 should have read, Agran PF: Motor vehicle occupant injuries in noncrash events. *Pediatrics* 1981;67:838-840.

In the article, "Prospective Surveillance of *Haemophilus influenzae* Type b Disease in Dallas County, Texas, and in Minnesota," by Murphy et al (*Pediatrics* 1987;79:173-180), there is an error in Table 2 and there are two errors in Table 3. In Tables 2 and 3, the last boxhead above the straddle rule should read, No. of Cases Observed (Incidence/100,000 Person Years). In Table 3, the footnote referring to the last boxhead beneath the straddle rule and black Dallas children should be a double dagger (‡), ie, 80(154)‡.
