

not controversial and is entirely consistent with current labeling and recommendations for use of the retinoid compounds. There was no intent on the part of the Committee on Drugs to slight any particular professional group. It is common practice for the Committee on Drugs as well as the other technical committees of the Academy to consult with various groups with overlapping interests and expertise during the preparation of a commentary or policy statement. In this case, this was not done because the statement was a revision of an existing statement and the content of the

statement was felt to represent a consensus of the medical community.
